NEED

The Sustainable Development Goals (SDGs) known as "Transforming our World: the 2030 Agenda for Sustainable Development" are a new sets of 17 universal goals, targets and indicators that 193 countries in the world have jointly set to end poverty, protect the planet and ensure prosperity for all on September 25th 2015. Though, the goals are universal but the implications and intervention possibilities are local. The Government of India, being active partner, has also worked out the activity mapping of each goal to be achieved and which will guide the policy and funding for the next 13 years. The NITI Ayog is the Nodal agencies for implemental. The Ayog is also working with states to seek their involvement in the country's policy decisions and engage with SDGs 2030. In response to the role and responsibilities, some of the state governments have already come with their own state specific plan of action to attain the goals and targets of Sustainable Development Agenda 2030. The Centrally Sponsored Schemes (CSSs), including the 'core of the core', 'core' and 'optional' Schemes being implemented by the States have also been mapped along with some of the recent initiatives undertaken by the Central Government. In addition, Ministries are implementing Central Sector Schemes and States are also implementing various State Schemes aligned with one or more SDGs. In this context the role of District level officials are very crucial.

In this context, a workshop is proposed to document the learnings and to provide the insight for the future course of Action.
