NEED

The State of Sikkim is called the Kingdom of the Indian Eastern Himalayas Region (IEHR). The region in which the State of Sikkim falls plays a vital role in sustaining diversity of life and livelihoods of millions of people living in mountainous areas and in its downstream river basins for food and energy production. But the region is risk-prone, ecologically fragile and vulnerable to natural calamities.

It is a matter of fact that all the states of IEHR region including Sikkim fall in the Special Category status that enable the states to get special assistance but due to lack of proper planning framework and inter-departmental coordination, the states are still marked as backward.

There is no doubt that the state of Sikkim needs economic growth. But this development cannot come at the cost of the environment and interest of local people. Therefore, there is need of a suitable development strategy for the State of Sikkim that takes into account the hilly terrain, its people interest, vulnerability of the region and the need for environment protection. The development strategy for this region/ States must be based on the region's/ States' natural & human resources forests, water, biodiversity, organic and nature tourism.

Now we have new planning framework with 17 universal Sustainable Development Goals adopted by the United Nations General assembly in September 2015. The sets of SDGs, i.e. to end poverty, protect the planet and ensure prosperity for all, are universal but the implications and intervention possibilities are local. Giving the utmost priority, the Government of India has worked out the activity mapping of each of the

goals to be achieved and which will guide the policy and funding for the next 13 years.

For the local level planning specially at the state level, mapping of activities, inter-departmental coordination and convergence is utmost. The inter-departmental coordination and convergence in the states falls under the Zone II of Indian Himalayan region are crucial and complex since the Himalayan ecosystem is considered as very fragile and diverse all over India.

In this context, a training programme is proposed to provide relevant knowledge on SDGs and activity mapping of SDGs at state level. The training will also focus on inter-departmental coordination for participatory planning, convergence of various programmes and share the best practices to achieve the SDGs.

Target Stakeholders: Senior Officers from RMDD, Panchayati Raj and Line Dept.
