3. The tender shall be submitted online in two parts, viz., Technical Bi d and Financial Bid through GeM biding system.

4. The bidder should be OEM authorized partner/ seller/ service provider of the item (firewall). OEM authorization letter from respective manufacturer should to be submitted.

5. Bidders should have ISO 9001 certificate.

6. The bidder should have average annual turnover of Rs. 25,00, 0
00/- (Rupees Twenty Five Lakhs only) during last three years.

7. Bidders must submit all relevant documentary evidence required t o demonstrate their eligibility for the proposed tender.

8. The bidder must be from a reputed Firm / Organization having prov en track record in supply,

9. Bidder should have experience of supply, installation, configuration , integration and service of UTM Devices. Minimum (03) three supply orde rs/ completion certificates during last 3 years in any Central/ State Gover

nment Organization/ PSU's /Government Educational Institutions are required to be furnished.
