

NOTIFICATION - CALL FOR QUOTATIONS

Subject: Sealed Quotations in the prescribed proforma (Appendix 'A') are invited by the undersigned for the work '**Rectification and Performance Enhancement of Deep Tube Well at NIRDPR-NERC**'.

Scope of Work: The scope of work includes rectifying the low discharge issue of the existing deep tube well at NIRDPR-NERC. This involves replacing the submersible pump, column pipes, and, if required, performing compressor washing and additional drilling to restore and optimize water output efficiency.

Dear Sirs,

1. You are requested to quote the rates for the items shown in the Appendix 'A' separately attached to this notification. The rates must be quoted only on the attached paper as per our specifications.
2. It should be noted that some of the items listed in the schedule of works in 'Appendix A' may not be required during execution, depending on the site conditions. Therefore, billing shall be based on the actual work completed at the site after the work order is allotted to the suitable firm / enterprise and the execution is carried out.
3. Following shall be taken note of while quoting the rates:-
 - a) The rates shall be inclusive of all transport charges, water charges, electrical charges etc.
 - b) Warranty/Guarantee/All contractual obligations should be mentioned clearly.
 - c) The materials to be installed shall be as described in the work specifications in Appendix 'A' and shall be of reputed brands.
 - d) Quotation received later than due date are liable to be ignored/rejected.
 - e) All details of the firm / enterprise shall be filled in the blanks available in Appendix 'A'.
 - f) Seal and Signature of the firm shall be attached at the bottom of Appendix 'A' after quoting rates.
 - g) The quotation must be submitted in sealed envelope super scribing "**Quotation For: Rectification and Performance Enhancement of Deep Tube Well at NIRDPR-NERC.**"
